

Eggs Overnight™, Inc. Privacy Policy

We do not intentionally collect non-public personally identifiable information from our clients. If such information is inadvertently collected, we do not typically share such information with third parties except as necessary to provide services to our clients and for the other specific purposes described below.

Visiting Our Website

You can visit the Eggs Overnight™ website (“Website”) without identifying yourself or revealing any personal information. Eggs Overnight™ collects and monitors user traffic patterns throughout the Website according to non-personally identifiable information such as a user’s domain name, IP address, browser type, date and time of access, and pages viewed. This non-personally identifiable information is collected in order to measure the number of visitors to our Website and to determine which areas of the Website receive the most traffic.

Information We Collect and How We Use It

How We Collect Information. We get most information directly from our clients, when our clients access and use our Internet services (“Services”). We collect business information (“Business Information”) when a client or visitor registers as a customer to use our Services or otherwise uses our Services. Visitors to our Website may also provide Business Information and other data by completing questionnaires and participating in surveys that are periodically posted on our Website.

How We Use Information. We may share Business Information or other data collected from visitors and clients with our business associates, including unaffiliated third parties, who assist us in administering the Services. We may use, share, or transfer Business Information or other data collected from visitors and clients:

- to provide enhanced services;
- to resolve client disputes;
- to maintain and service our systems;
- to protect the confidentiality or security of client records;
- to law enforcement or other government officials to protect Eggs Overnight™, Inc. or our clients, or in connection with an investigation or prosecution of possible unlawful activity;
- in connection with a sale or merger of Eggs Overnight™, Inc.;
- to our attorneys, accountants, and regulators; or
- for other legally permissible purposes.

We may also use or share Business Information and other data provided by clients or visitors with trusted affiliates, independent contractors, and other businesses for Eggs Overnight’s™ marketing and business purposes.

Information Collected by Third Parties
